Subject: National Para Shooting Selection Trials 1 & 2 – 2026 for Rifle, Pistol, Shotgun & VI Events at the AMU Shooting Ranges, MHOW, Indore, M.P. (Men & Women) from 17th to 25th May 2026 – Selection for Novi Sad 2026 WSPS World Cup, Changwon WSPS World Championship & 5th Asian Para Games, AND OTHER INTERNATIONAL COMPETITIONS.

Dear Shooters,

In accordance with the Selection Policy 2025-26, it has been decided to hold a **National Para Shooting Selection Trial No. 1 & 2, 2026** in Men and Women Events at **AMU Shooting Ranges, MHOW, Indore, M.P. from 17th – 25th May 2026.**

Scores will be entered in the main log sheet for calculating the average and will be valid for selection in subsequent International Competition as per Selection Policy

These trials will be organized and conducted by STC Shooting, Paralympic Committee of India (PCI). Shooters who have **PARTICIPATED** in the following competitions will be allowed to participate in these trials:

IMPORTANT

- Any National Championship or Selection Trials Conducted by STC – Para Shooting, Paralympic Committee of India but **those who have participated in the 6th National Para Championship are only eligible to participate at the international competitions and would be considered for the selection of above-mentioned international competitions (Please refer selection policy 2026-27 on www.parashooting.in website).**

- To select the Indian Para Shooting Team for 5th Asian Para Games, selection criteria from Ministry of Youth Affairs and Sports would also be adhered to (letter no. 70-9/2025-Governance-I)

A. GENERAL TERMS AND CONDITIONS, PARTICIPATION, ENTRY FEES & ENTRY FORM

1. All participants are requested to go through the above instruction carefully and ensure strict compliance.
2. All participants are expected to abide by the rules and regulations of the competition. Discipline on and off the field is very essential.
3. In case of non-participation Entry Fee once paid will not be refunded.
4. The tentative program is attached herewith in Annexure "A".
5. Details of the entry fee is attached in Annexure "B".
6. Entry Form is attached in Annexure "C".
7. Entries will only be accepted by email at theparashootingindia@gmail.com
8. Entries with normal fee will be accepted till **5th May 2026 at 9:00 PM**. Late entries with triple entry fee will be accepted till **7th May 2026 at 9:00 PM**.
9. Athletes will have to make their own arrangements for arms and ammunition.
10. On the Spot entries will not be accepted.
11. Sharing of gun is not allowed.
12. Medical classification is mandatory.
13. Entry once submitted cannot be cancelled.
14. Organizing Committee have rights for any essential changes.
15. Accommodation to be arranged by the participants only.
16. Shooting Practice in the hotels is prohibited.
17. Organizing Committee reserves the right to amend rules and regulation for smooth conduct of the national selection trials.

3. Scan the Signed Entry form along with all the required documents.

5. All Athletes, while submitting the entries, must attach a photocopy of their Valid Passport or Photo Identity Card (Aadhaar Card, Arms License, Driving License etc.), Valid IPC License / PCI Medical Classification Card, and Transaction Receipt and its details in Entry Form.

E. DISCIPLINE:

1. Paralympic Committee of India and STC Para Shooting expects highest order of discipline from the Shooter, Coach, Escort and Accompanying person during the matches. Indiscipline on and off the field will not be tolerated and in such cases, Athletes will be disqualified and may be debarred for 02 years to participate in any competitions.
2. Athletes, Coaches, Escorts and Accompanying persons are not allowed to go beyond the firing line.

Competitor Card would be sent to the Athletes Email ID as provided in the Entry Form. Kindly bring the copy of the Competitor Card with you.

Athletes have to declare use of medicines if any for TUE (Therapeutic Use Exemption) as per Anti-Doping Rules and Regulations.
